#### NOMINATION PROCEDURE

Any member seeking election as a delegate or any delegate seeking re-election must file a signed, written nomination (early nomination), co-signed by another member within the same sub-zone. This nomination may be forwarded by mail, or email to the Secretary-Treasurer of the Board (Brian O'Connor) but must be received by **5:00 p.m. on Friday, October 27, 2023**. #### **QUALIFICATIONS FOR A DELEGATE**

Each delegate shall have attained the age of majority (18 years) and at the time of election shall personally be a member, or a member of a partnership which is a member, or a shareholder of a Corporation which is a member and shall not be in arrears in respect of any call for fees, assessments, or charges. An employee of EastGen or his/her spouse cannot be a delegate.

#### ROLE OF A DELEGATE AND EXPECTED TIME COMMITMENT

A delegate plays an important role in the governance of EastGen. They provide a two-way communication link between members and the Board of Directors. EastGen encourages a strong pro-active delegate body to maintain a successful and extensive member base. Delegates are responsible for attending the Annual Meeting, a general Delegate Meeting, and Zone (Virtual, Hall and/or Barn) Meetings.

#### **ELECTION OF DELEGATES IN SUB-ZONES**

When the number of nominations received in the sub-zone is equal to the number of eligible delegate positions the nominee(s) is/are acclaimed as delegate(s).

If more nominations are received than the open positions a vote will be held by mail-in ballot to fill the delegate positions. Individuals nominated who do not fill a delegate position through the election will become alternate delegates.

If no nominations are received, the Board of Directors may appoint a delegate to fill this vacancy.

### **ALTERNATE DELEGATES**

Each Zone or Sub-zone may elect one (1) Alternate Delegate for each four (4) eligible Delegates or portion thereof. If more than one (1) Alternate Delegate shall be elected from a Zone or Sub-zone, the Alternate Delegates shall be numbered as First Alternate, Second Alternate, Third Alternate, and so on, on the basis that the highest number of votes shall be Alternate Delegate one, the second highest shall be Alternate Delegate two and so on.
